#### **MONROE COUNTY INCIDENTS OF DOMESTIC VIOLENCE 2014**

### 4,709 reports of domestic violence were made in Monroe County in 2014



In 2014, there were 63 reports of domestic violence per 10,000 residents in Monroe County

City of Rochester rate was 111, more than two and a half times the statewide rate of 46 (excluding New York City)

Rates have declined for each of the past three years in Monroe County and the City of Rochester, while the statewide rates have remained flat.

#### **DOMESTIC VIOLENCE IN EVERY ZIP CODE**

50,249 calls placed to 911 County Dispatch System in 2014 were classified as domestic disputes, down 6% compared to the 53,049 calls placed in 2013

#### **MONROE COUNTY FAMILY COURT ORDERS OF PROTECTION**



Sources: UCMS Order of Protection Report for Monroe County; Monroe County Probation Dept. The number of orders of protection filed **increased 30%** from 2008 to 2014. This is primarily a result of NYS legislation in 2008 which expanded the definition of domestic violence to include dating, LGBT couples, and intimate partners not living together.

In 2014, Monroe County Family Court filed **3,374 petitions**, down slightly from the 3,444 the year before. **91% of petitions filed were granted** a temporary order of protection, **up from 76%** granted the year before. Of petitions granted, 32% were granted final orders of protection.

A point-in-time count on January 1, 2014 reported 462 domestic violence offenders on active probation.

#### **DOMESTIC VIOLENCE AND CHILDREN**

- Infants and small children who are exposed to violence in the home experience so much added emotional stress that it can harm the development of their brains and impair cognitive and sensory growth.
- The single best predictor of children becoming either perpetrators or victims of domestic violence later in life is whether or not they grow up in a home where there is domestic violence.
- Children who experience childhood trauma, including witnessing incidents of DV are at a greater risk of having serious adult health problems including tobacco use, substance abuse, obesity, cancer, heart disease, depression and a higher risk for unintended pregnancy.
- 30% to 60% of perpetrators of intimate partner violence also abuse children in the household.
